Model I - In-Clinic Programs that provide access to 8 for-profit clinics at an average discount fee of 72%. Many received care for the price of a co-pay. 1,331 patients' visits were provided to uninsured and low-income patients who would not have been able to have dental, eye care, physical therapy, pulmonology, cardiology, and other diagnostic services. \$182,090 in-kind donations were received from our partner providers in 2020.

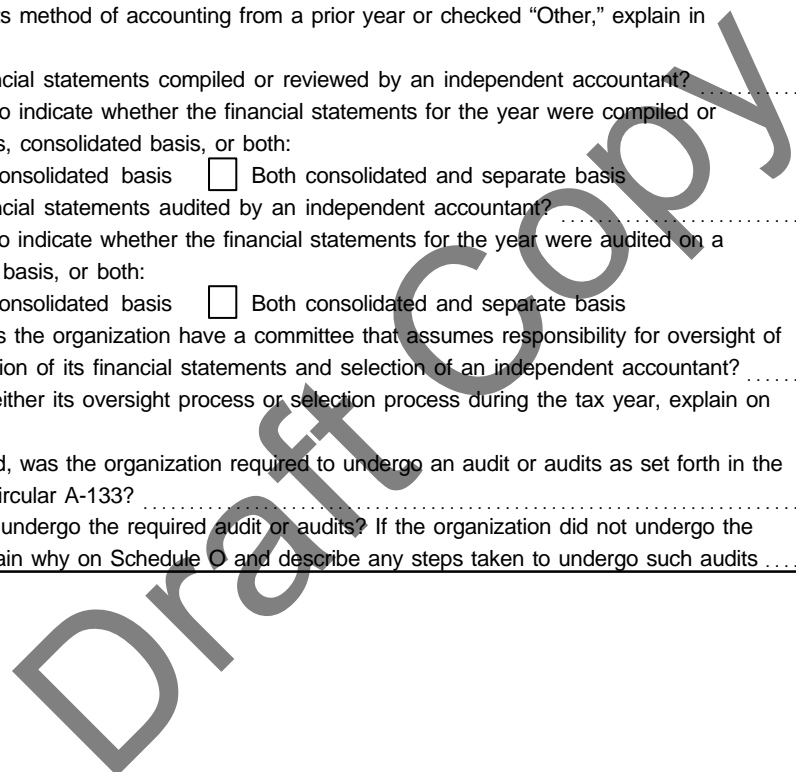

Form 990, Part III, Line 4a - First Accomplishment

The year saw Utah Partners for Health create new safety procedures, juggle staff, dive into telehealth, and partner with many organizations to test and care for our community during the COVID-19 pandemic. We served 5,933 patients and had a total of 14,486 visits for medical, dental, behavioral health, and optometry. We adapted and provided 3,307 telehealth visits during the year to keep our patients safe. We responded to a request by the Department of Health to increase testing among ethnic populations and tested 1,689 patients using our mobile medical clinic. As we look forward to 2021, we are planning to continue to provide quality and coordinated care by adding an optical center and pharmacy. Our 2020 needs assessment identifies both services as a gap for underserved populations.

At Utah Partners for Health, we have several Models to address patient needs:

- Model I - In-Clinic Programs that provide access to 10 for-profit clinics at an average discount fees of 70%. Many received care for the price of a co-pay. Individuals receive dental, eye care, physical therapy, pulmonology, cardiology, and other diagnostic services. \$194,992 in-kind donations were received from our partner providers in 2020.

- Model II - The UPFH Mobile Medical Clinic program breaks down barriers such as transportation, language, and lack of understanding of our health care system. This clinic provides free care for uninsured patients with

incomes less than 200% FPL. This program was shut down for much of 2020, but we are scheduled to go back online the middle of February to 41 different sites in Salt Lake and Tooele Counties.

- Model II - Mobile Eye Care Clinics visit area schools with the poorest children. This program works with school nurses and the United Way to improve educational outcomes for students with vision impairment. We were still able to provide 1,129 patients with eye exams and 1,080 free glasses.

- Model III - Mid-Valley Health Clinic and the Utah Partners For Health Family Clinic are Federally Qualified Health Centers offering a deeply discounted sliding fee schedule for individuals with incomes 200% or less of the Federal Poverty Level. This clinic provided 8,183 primary care visits in 2020.

- Model III - Utah Partners for Health Dental Clinic provided 2,754 low-cost visits. Patients are treated with the goal of good oral health, and care extends to crowns, dentures, implants, and limited orthodontics.

- Model III - Utah Partners for Health Behavioral Health Clinic provided 1,498 counseling visits including no cost visits for homeless individuals. Demand for this service increased by 42.6% in 2020.

In 2020 we achieved clinical performance measures in: Adult Weight and Counseling, Asthma, Depression, Immunizations, And Diabetes. We improved in Cervical and Colorectal Cancer Screening but missed our internal goals.
