

Federally Qualified Health Centers:

- Our Model II - Mobile Medical Clinic has expanded to provide care three days a week in 26 different neighborhoods and provided 1,611 medical visits to families in their own neighborhood. These individuals experience barriers in accessing care such as language, transportation, income, and lack of understanding of our health care system.

- Our Model II - Mobile Eye Care clinic is in such demand that we added a second event each week in 2015. This program reached out to Title 1 schools providing exams and glasses for students and their families. This program is dramatically improving educational outcomes for students with vision impairment. A total of 1,127 individuals needing glasses were given an exam, with 556 students receiving a free pair of lenses.

- Our Model III - Mid-Valley Health clinic also expanded in 2015. The clinic is a Federally Qualified Health Center offering a deeply discounted sliding fee schedule for individuals with incomes 200% or less of the Federal Poverty Level. The clinic continues to grow and served 3,013 individuals in 2015 providing 6,767 medical encounters.

- We are proud to announce Utah Partners for Health has earned The Joint Commission's Gold Seal of Approval® for Ambulatory Health Care Accreditation by demonstrating continuous compliance with its nationally-
